Learning objective

Learn simple adult-led rules for privacy, kindness and asking before links, messages, photos or purchases.

Use this pack well

- Model the first example aloud, then let the learner try.
- Ask “How do you know?” more often than “Are you finished?”.
- Use real objects, talk, movement or observation when the activity suggests it.
- Stop or shorten the session if attention or enjoyment drops.
- Open-ended pages can have many successful answers.

Learn the idea

1 personal information should be protected

2 online kindness matters

3 children should ask a trusted adult before external links, purchases or contact

Talk about it

Explain one idea in your own words. Give an example from real life, a drawing or an object if that helps.

Sort information into “private - ask adult” and “okay in a classroom story”.

Choose a kind response in a fictional game scenario.

Explain why a stranger online is still a stranger even with a friendly avatar.

Practise closing a confusing pop-up and asking an adult.

Identify why photos should not be shared without permission.

Try it beyond the page

Real-world / hands-on connection

Try one activity in real life with a trusted adult or teacher and discuss what worked.

Answer & discussion notes

A trusted adult/teacher/family member may be named without private details.

3. Suggested response

The next step should be small and achievable.

Review before publication

Check age fit, factual accuracy, clarity, accessibility, rights provenance and whether the activity works in practice. This file remains a review copy until those checks are signed off.
