Learning objective

Visualise simple 3D forms from nets and viewpoints using physical checking where possible.

Use this pack well

- Model the first example aloud, then let the learner try.
- Ask “How do you know?” more often than “Are you finished?”.
- Use real objects, talk, movement or observation when the activity suggests it.
- Stop or shorten the session if attention or enjoyment drops.
- Open-ended pages can have many successful answers.

Learn the idea

1 A net is a 2D arrangement that can fold into a 3D form.

2 Different viewpoints show different visible faces.

3 Physical models can verify mental rotation.

Talk about it

Explain one idea in your own words. Give an example from real life, a drawing or an object if that helps.

Choose which cross-like net can form a cube from simple examples.

Predict which faces meet after folding.

Draw front/top views of a block arrangement.

Rotate a paper model and compare with prediction.

Identify a net that overlaps when folded.

Try it beyond the page

Real-world / hands-on connection

Cut/fold only adult-approved simple paper nets or use digital models; avoid sharp tools without supervision.

Before you finish

What did you notice?

What evidence, object or example helped you?

What would you change if you tried again?

Create something

Your project

Design a decorated cube net where opposite faces follow a rule, then verify by folding.

Use this space for planning, drawing, mapping, designing or notes.

Think deeper

1. Which strategy reduced uncertainty or work?

2. How did you verify the final answer?

3. When would changing strategy be sensible?

Quick review

1. In one sentence, explain the big idea of “Spatial Reasoning: Nets, Folds & Views”.

2. Draw or write one example that shows you understand.

3. Choose one activity from this pack and explain the strategy you used.

4. Write one question you still have.

Answer & discussion notes

Use these as guidance, not scripts. Open questions can have different successful responses when the reasoning is sensible and evidence-based.

1. Suggested response

Name the strategy and why it fit.

2. Suggested response

Use a second method, inverse operation, full clue check or model as appropriate.

3. Suggested response

When the current method is inefficient, confusing or produces a contradiction.

Review before publication

Check age fit, factual accuracy, clarity, accessibility, rights provenance and whether the activity works in practice. This file remains a review copy until those checks are signed off.
